The State government incentive schemes – Supply side has two parts – Fiscal and Non-Fiscal. The Fiscal incentive scheme includes • Capital subsidy linked to investment outlay • Training subsidy linked to job creation • Gross or Net GST refund on supply of goods or services • Exemption or concession from stamp duty on transfer or lease of land • Concessional rates of power tariff • Concessional land • Interest free loans • Sector specific policies

The Non-Fiscal incentive scheme includes • Single window clearance for permits • Infrastructure benefits viz roads, water supply, IT infrastructure etc

Madhya Pradesh is one of the States that is offered moderate incentives among others like Delhi, Haryana, Punjab, Rajasthan, Uttar Pradesh, Himachal Pradesh.

PLI will also help bring in business opportunities of developing new business models and entering new markets. It will help in changing business model by evaluating alternative business models for eligible auto OEMs – e.g. feasibility to now manufacture in India rather than CKD / SKDs. With the PLI the FDI inflow from global companies into eligible products / companies will increase. New Product Introduction - Under PLI scheme, eligible companies can expand their portfolio, to offer products from the 22 segments, aligning their portfolio with growing segments.

The Production Linked Incentive (PLI) is supposed to be a game changer Scheme, it has helped in drawing huge investment to the country and also in building manufacturing capabilities. The scheme, announced in the Union Budget 2021-22 with an outlay of Rs 1.97 lakh crore, covers 13 champion sectors like textile, steel, telecom, automobiles and pharmaceuticals.
